Important Notes:

2023 SCHOOL FEES

Please be guided by the 2022 School Fees: Grades 1 – 3 R23 513.00, including stationery and Grades 4 – 7 R22 641.00, excluding stationery, per annum per learner. The 2023 fees are subject to budgetary requirements and approval by the parents at the Parents' Annual Budget Meeting scheduled for October 2022, date to be confirmed. **The 2023 pre-payment of R3 300.00, which forms part of the total annual fee, is payable on acceptance or on or before 30 November 2022** and will be credited to your school fee account. The balance is payable in 9 equal instalments commencing on 31 January 2023 and ending on 30 September 2023.

Please Note: That should school and/or After School Centre fees be outstanding for learners currently in the school or for past learners of the school, a monthly Debit Order will have to be signed for the 2023 applicant for the school and/or After School Centre fees.

AFTER SCHOOL CENTRE (ASC)

Please be guided by the 2022 fee which is R10 667.00 per child per annum. **The 2023 pre-payment of R500.00** per child is payable upon acceptance to secure your child's place and will form part of the 2023 fees. The pre-payment is not refundable if you do not inform the School, in writing, that your child will not attend the ASC in 2023. The pre-payment must be paid for all applications.

GRADE 1 – 3 STATIONERY PACKS

Grade 1 – school bag and stationery included in School Fees.

Grades 2 and 3 – stationery packs only are included in School Fees.

GRADES 4 – 7 STATIONERY PACKS

Stationery packs will **NOT** be provided (Stationery lists supplied).

FEEDER ZONE

Area: east of N1, south of Atterbury Road to Grootfontein, (Constantia Park, De Beers, Erasmuskloof, Elardus Park, Faerie Glen south of Atterbury Road, Garsfontein, Grootfontein Plots, Menlyn, Mooikloof, Moreleta Park, Newlands east of N1, Olympus, Plots and Small holdings east of Glenstantia, Pretorius Park, Rietvallei Park, View and Rand, Rietvlei, The Hills, The Wilds, Tierpoort, Waterkloof Glen, Wingate Manor and Park, Woodhill and Woodlands).

ADMISSION REQUIREMENTS

- UNABRIDGED (Full) BIRTH CERTIFICATE - has both biological parents and child's full birth information on one form. It can be obtained from the Department of Home Affairs. Proof of application is required – receipt / till slip.
- Grade 1: preference is given to learners who turn 7 (seven).
- ADMISSION: FIRSTLY (A) - Admission may be granted, subject to availability of classroom space, to learners of parents residing within the defined feeder zone. (Residing implies ownership of a dwelling or leasehold or rental thereof which is valid for 2022/2023.) SECONDLY (B) - if the applicant learner has a sibling in the school for the year for which they are applying, subject to availability of classroom space. THIRDLY (C) - if at least one of the applicant's parent's place of employment is within the defined feeder zone, subject to availability of classroom space. *This falls in-line with the Gauteng Department of Education Regulations governing admissions published in 2020.*
- The feeder area is defined by the School Governing Body as per the South African Schools Act, Act 84 of 1996. Published in Provincial Notice 1232 of 2018.
- Foreign Learners: In accordance with the Immigration Act, Act 13 of 2002, Sections 13 Study Visa, 23 Asylum Transit Visa and 25 Permanent Residence Permits. Immigrant Regulations (GG 37679 dated 22/05/2014) learners and parents who are non-South African citizens ***must be in possession of a valid Passport and Study/Work Visa and the fees must be paid in full in advance.***
- Foreign learners and SA learners educated outside SA are placed with their peer group.
- Water Safety: As swimming forms part of our Physical Education curriculum all learners must be water safe.

DEFINITION OF A "PARENT"

A "parent" is the biological parent or the legal guardian of a learner, or

A "parent" is a person legally entitled to the custody of a learner or

A "parent" is a person who usually has the care and control of a learner.
