<u>The Grade R class is a self-funding class</u> no exemptions are available. A Pre-payment of R3300.00 per learner is payable on acceptance. The balance is payable in advance.

The Enrolment Form and all supporting documentation can be placed in an envelope/plastic sleeve in the drop box at the main pedestrian gate **OR** submitted, in person, by making an appointment with Ms Kuzwayo between 07:30 – 12:30 **OR** sent with a sibling in the school to submit to Ms Kuzwayo. Only applicants from outside Pretoria may email the completed form and supporting documents to admissions@glenstantia.co.za

Admission Hours: Mondays - Fridays, 07:30 - 13:00.

 - Original lease agreement in your name, valid for 2024, and CURRENT Rental Statement / Lights & Water account, if renting - subletting is not considered as proof of residence.
 - · Offer to Purchase with conditions met.
 - Proof of residence must be Fica compliant. (See Important Notes below).
- 1.6 Proof of Permanent Employment within feeder area will be required if the applicant does not own or rent a property. (See GDE placement criteria, Appendix A attached refers.)
- 1.7 Certified copy of **BOTH parents**' *I* guardians' *I* custodians' Identity Documents, *irrespective* of *living arrangements*. Both parents must sign the Enrolment Form.
- 1.8 If not a S A Citizen: certified copy of learner's Passport and valid Temporary Residence Visa / Study Visa / Permanent Residence Permit / Asylum or Refugee Permit. Both parents' Passports with valid Work Visas / Temporary Residence Visas / Permanent Residence Permits / Asylum or Refugee Permits and Medical Aid Policy. (see Appendix A attached).
- 1.9 SASSA Card and Letter from SASSA indicating beneficiaries.
- 1.10 1x Colour Passport photo / 2023 school photo.

Important Notes:

- Only children born between <u>1 January and 31 December 2018</u> or those who have turned six already will be considered for the Grade R class.
- Only learners who live with their parents/legal guardians in houses owned or rented by them, will be considered. Subletting is not considered as proof of residence.
- Placement criteria will be as per the GDE 2020 Admissions regulations, Appendix A attached refers.

Page 1 of 2 Strive Joyfully! - <u>If the applicant does not own or rent a property</u>, we will require the <u>latest</u> Bank Account in your name reflecting the residential address OR 2023/2024 SARS IT34 Assessment. (<u>Sworn Affidavits will not be accepted</u>).

- Supporting Documentation: The original will be requested if copy is unclear.

- Water Safety: As swimming forms part of our Physical Education curriculum it is your responsibility to ensure that your child is water safe before coming to our school.
- Your application will ONLY be considered if ALL the required documentation has been received or arrangements have been made for late submission thereof and submitted by due date.
- The Grade R 2 After Care may move off-site later in the year.
- 2. Please note that it is imperative that you honour your financial commitment to the School.

Appendix A

2024 SCHOOL FEES

The Grade R class is a self-funding class. NO exemptions are available. Please be guided by the 2023 School Fees which are R25 106.00 per annum per learner. The 2024 fees are subject to budgetary requirements and approval by the parents at the Parents' Annual Budget Meeting scheduled for October 2023, date to be confirmed. The 2024 pre-payment of R3 300.00 per learner, which forms part of the total annual fee, is payable on acceptance and will be credited to your school fee account. The balance of the fees is payable in 9 equal instalments commencing on 31 January 2024 and ending on 30 September 2024.

<u>Please Note:</u> That should school and / or After School Centre fees be outstanding for a learner/s currently in the school or for past learners of the school, the Grade R 2024 applicant will not be accepted until all the outstanding fees have been paid up in full. Once all the outstanding fees have been paid in full and should the Grade R learner be accepted for 2024, a monthly Debit Order will have to be signed for the 2024 school and / or After School Centre fees for the sibling/s as well as the Grade R 2024 learner.

AFTER SCHOOL CENTRE (ASC)

Please be guided by the 2023 fee which is R8 405.00 per child per annum. The 2024 pre-payment of R500.00 per learner is payable upon acceptance to secure your child's place and will form part of the 2024 fees. The pre-payment fee is not refundable if you do not inform the school, in writing, that your child will not attend the ASC in 2024. The pre-payment fee must be paid for all applications. The Grade R – 2 After Care will move off-site in late 2023

Area: east of N1, south of Atterbury Road to Grootfontein,

(Constantia Park, De Beers, Erasmuskloof, Elardus Park, Faerie Glen south of Atterbury Road, Garsfontein, Grootfontein Plots, Menlyn, Mooikloof, Moreleta Park, Newlands east of N1, Olympus, Plots and Small holdings east of Glenstantia, Pretorius Park, Rietvallei Park, View and Rand, Rietvlei, The Hills, The Wilds, Tierpoort, Waterkloof Glen, Wingate Manor and Park, Woodhill and Woodlands).

ADMISSION REQUIREMENTS

- <u>UNABRIDGED</u> (Full) <u>BIRTH CERTIFICATE</u> has both biological parents and child's full birth information on one form. It can be obtained from the Department of Home Affairs. Proof of application is required receipt / till slip.
- Only children born between January and December of the year they turn six or those who have turned six already will be considered.
- <u>ADMISSION: FIRSTLY</u> (A) Admission may be granted, subject to availability of classroom space, to learners of <u>parents residing within the defined feeder zone</u>. (Residing implies ownership of a dwelling or leasehold or rental thereof which is valid for 2023/2024.) <u>SECONDLY</u> (B) if the applicant learner <u>has a sibling in the school</u> for the year for which they are applying, subject to availability of classroom space. <u>THIRDLY</u> (C) if at least one the applicant's <u>parent's place of employment is within the defined feeder zone</u>, subject to availability of classroom space. <u>This falls in-line with the Gauteng Department of Education Regulations governing admissions published in 2020</u>.
- The feeder area is defined by the School Governing Body as per the South African Schools Act, Act 84 of 1996. Published in Provincial Notice 1232 of 2018.
- Foreign Learners: In accordance with the Immigration Act, Act 13 of 2002, Sections 13 Study Visa, 23 Asylum Transit Visa and 25 Permanent Residence Permits. Immigrant Regulations (GG 37679 dated 22/05/2014) learners and parents who are non-South African citizens must be in possession of a valid Passport and Study/Work Visa and the fees must be paid in full in advance.
- Foreign learners and SA learners educated outside SA are placed with their peer group.
- Water Safety: As swimming forms part of our Physical Education curriculum all learners must be water safe.

DEFINITION OF A "PARENT"

A "parent" is the biological parent or the legal guardian of a learner, or

A "parent" is a person legally entitled to the custody of a learner, or

A "parent" is a person who usually has the care and control of a learner.

The school will require a copy of the documents (Court Order or letter from Social Services) conferring guardianship or custody of the learner to a person other than the biological parents as proof of legal rights to fulfil the obligation of Parents / Guardians.

BASELINE ASSESSMENT - All applicants will undergo a baseline assessment to determine the entry level of the learners, thereby ensuring a fair distribution of abilities within the grade.
